FOREWORD

In 2014, antisemitic crime broke all previous records. Many linked the surge in Jew-hatred across Britain to fighting between Israel and Hamas, and expected antisemitic crime levels to fall to a background level. That is not what happened.

Our team has analysed data provided from all of the police forces in the United Kingdom.

We now know that in 2015:

- Police forces recorded a 25.7% increase in hate crime against Jews, making it the worst year on record for antisemitic crime. The level of antisemitic crime was consistently high throughout the year.
- Violent antisemitic crime jumped by 50.8%. In 2014 violent acts accounted for 16.9% of all antisemitic crime, but by 2015 violent acts accounted for 20.3% of antisemitic crime.
- Despite the growth in antisemitic crime, police forces charged 7.2% fewer cases in 2015 than in 2014, meaning that only 13.6% of cases resulted in charges being brought.
- There was no change in the non-criminal antisemitic acts reported to the police, meaning that in 2015 a higher proportion of the antisemitic acts reported to the police were criminal.

When the current wave of antisemitism began in 2014, politicians and police chiefs were quick to promise tough action. The day after Campaign Against

Antisemitism rallied outside the Royal Courts of Justice, the Prime Minister echoed our call for zero tolerance law enforcement against antisemites.

The promised crackdown has not materialised. In far too many cases, rank and file police officers and prosecutors often do not recognise some of the forms of antisemitism, or fail to take it seriously. Officers and prosecutors are not being given sufficient training or oversight.

The results speak for themselves.

Antisemitic crime is climbing fast, violence against Jews is soaring, and the police response is gradually getting worse. If Britain is to escape the fate of other European countries, where antisemitism and extremism are rife and Jews are leaving in their thousands, we must train our frontline police officers and prosecutors, and properly oversee them.

We recommend:

- Specific training and guidance on antisemitic hate crime for officers and prosecutors, produced in close consultation with us, in addition to the generic hate crime training that leaves officers and prosecutors ill-equipped to deal with the intricacies of antisemitism.
- A review of all forces by Her Majesty's Inspectorate of Constabulary and the appointment of a senior officer in each force with responsibility for overseeing the response to antisemitic hate crime.
- Recording and regular publication by the Crown Prosecution Service of cases involving antisemitism and their outcomes.

This data should alarm those responsible for enforcing the law: they are failing British Jews badly. Britain has the political will to fight antisemitism and strong laws with which to do it, but in too many cases, those responsible for tackling the rapidly growing racist targeting of British Jews are failing to enforce the law.

If the situation continues to deteriorate, the Jewish community will be faced with the kind of rampant antisemitism seen in other European countries, which has left Jews feeling fearful and abandoned, many of them convinced that they have no choice but to emigrate.

The time to act was 2014. The authorities can still make up for lost time, but the window is closing. Britain's fight against antisemitism and extremism cannot be allowed to fail.

NATIONAL DATA

CONSISTENTLY ELEVATED LEVEL OF ANTISEMITIC CRIME

In all but eight of the forty-five geographic police forces surveyed, there was an increase in antisemitic crime in 2015 compared to 2014.

Police forces across the United Kingdom recorded 746 antisemitic crimes in 2014, but that rose to 938 antisemitic crimes in 2015, representing a **25.7% rise**.

Of particular note is that whereas 28.9% of antisemitic crime in 2014 occurred during the months of July, August and November,


there were no similar peaks in 2015 and the level of antisemitic crime was consistently high every month. Indeed, any given month in 2015 saw about twice as much antisemitic crime as any of the first six months of 2014, prior to the fighting between Israel and Hamas in July and August 2014.

Expectations that antisemitic crime would gradually return to levels seen prior to the 2014 war in Gaza were proved incorrect. Instead, a consistently elevated level of antisemitic crime was established as the new normality for British Jews.

One explanation could be that antisemitic crime is ratcheting up such that during a trigger incident, such as a war involving

Israel, people are persuaded to adopt hatred of Jewish people. This would explain the fact that after the peak in antisemitic crime in July and August, the level of antisemitic crime remained higher than it had been previously.

Another explanation is that there are not necessarily more antisemites, but that those engaging in antisemitic acts are doing so more often, or more aggressively. This would be explained by the growth in antisemitism as a core part of far-left and Islamist ideology. Islamism continued to make gains in Britain in 2015, as did the far-left. Far-right groups also show signs of rejuvenation and have become much more active.

Without more granular crime data, it is not possible to say with any certainty whether the antisemitic crimes recorded by police forces were perpetrated by particular groups, or whether those convicted of antisemitic hate crimes were serial offenders.


FIFTY PERCENT LEAP IN ANTISEMITIC VIOLENCE

Violent antisemitic crimes recorded by police forces increased by 50.8%

between 2014 and 2015. Whereas in 2014, 126 violent antisemitic crimes were recorded, in 2015 there were 190. This means that as well as antisemitic crime increasing in volume, the nature of that crime is also escalating: in 2014, 16.9% of antisemitic crime involved violence, but in 2015 the proportion of antisemitic crimes

involving violence rose to 20.3%.

This means that on average in 2015, one in five antisemitic crimes involved an act of violence against a Jewish member of the public. In May and July 2015, one in four antisemitic crimes involved violence. The increase in violent antisemitic crime is an extremely worrying development.



The most likely explanation for such a large growth in antisemitic violence is the increasing evidence of antisemitism being used as a core component of the violent ideologies of Islamism and neo-Nazism, both of which continue to gain adherents. Whilst Islamists and neo-Nazis agree on little, they both agree that Jews are their enemy and must be violently oppressed. Their means of inciting such violence draw on themes and messages of the kind used by Nazi Germany, which are proliferating on social media and amongst students.

FAILURE TO CHARGE

One of the most startling revelations is that despite the promises to crack down on antisemitism and the huge surge in antisemitic crime to a record-breaking level, the number of antisemitic crimes charged in 2015 decreased.


Crimes take time to investigate, so increased charging would normally be

expected to lag behind increases in the number of crimes, however 2015 saw a decrease in the number of crimes charged.

Whilst only ten fewer cases were charged in 2015 than in 2014 — a small number in absolute terms — the growth in the number of crimes ought to have produced a corresponding increase in the number of cases charged.

There is considerable evidence of cases that police forces have mishandled, generally due to an inadequate recognition on the part of police officers of the nature of antisemitism and ignorance as to the offences that are relevant to antisemitic crime and how to investigate them. For example, many cases of antisemitic crime involve anti-Jewish racist discourse which many officers easily mistake for non-criminal political discourse.

The Crown Prosecution Service does not keep records of cases involving



antisemitism separately, so it is not possible to ascertain how many cases that were charged resulted in a prosecution, nor is it possible to know how many of those prosecutions succeeded.

NO CHANGE IN NON-CRIMINAL INCIDENTS


Police forces keep records of non-criminal incidents that are reported to them, however it should be stressed that incident data includes any report made to the police that is not criminal, which means that incidents are unqualified and may have no connection to criminality at all. Instead, incident data is provided as a means of judging whether police forces received a higher or lower number of non-criminal complaints.

The data provided by police forces showed no variation in the number of non-criminal

incidents recorded between 2014 and 2015; in both years, a total of 751 non-criminal incidents were recorded.

The number of incidents in each month follows fairly closely the number of crimes recorded in each month by the Metropolitan Police Service for reasons that are described in the methodology.

REGIONAL DATA

CONCENTRATION OF CRIME IN LONDON AND MANCHESTER

According to the 2011 census, 64.3% of British Jews live within the areas policed by the Metropolitan Police Service, City of London Police and Greater Manchester Police. Those police forces recorded antisemitic crimes amounting to 67.9% of the total number of antisemitic crimes committed in 2015.

MOST VIOLENT CRIME IS AGAINST SMALLER COMMUNITIES

Despite accounting for only 35.6% of the Jewish population, Jewish communities outside London and Manchester suffered 49.4% of violent antisemitic crime, meaning that **smaller Jewish communities**





disproportionately suffered from violent antisemitic crime.

When it comes to charging antisemitic crime, 56.1% of forces which received reports of antisemitic crime did not charge any of the 70 crimes reported to them.





RECOMMENDATIONS

TRAINING AND GUIDANCE

It is not always obvious to those without an understanding of the history of antisemitism when an antisemitic act has occurred. In our experience, frontline police officers and junior prosecutors rarely have experience of antisemitism, and might not recognise certain types of antisemitic behaviour or acts, for example following a Jewish person and imitating the sound of escaping gas, alleging the malevolent power of 'the Rothschilds' or calling a Jewish person a 'baby killer'. This is understandable: the Jewish population is small and many police officers and prosecutors will rarely deal with Jewish people or antisemitism. They need to receive training, and when confronted with antisemitism, they need an authoritative and accessible source of guidance.

We recommend specific training and guidance on antisemitic hate crime for officers and prosecutors should be produced by the College of Policing and the Crown Prosecution Service in close consultation with experts from Campaign Against Antisemitism. This specific training and guidance should supplement the generic hate crime training as it leaves officers and prosecutors under-equipped to deal with the intricacies of antisemitism. We will also produce guidance for victims of antisemitism who wish to see the law enforced.

OVERSIGHT

Law enforcement against antisemitic hate crime must be consistent and firm. In our experience, procedures and oversight within police forces fail to ensure that each and every response to antisemitism is as firm as the law permits. Learning from police forces which have established good practice in this area, we believe that the establishment of clear procedures and the nomination of a senior officer to oversee them is the most crucial element in developing deterrence against antisemitic hate crime through a consistently firm response.

We recommend the swift appointment by all police forces of a Single Point of Contact for antisemitic hate crime with a rank of Chief Superintendent or higher who has responsibility for overseeing investigations into reported antisemitic hate crime, and a review by Her Majesty's Inspectorate of Constabulary of all police forces' response to antisemitic hate crime, including online hate crime, hate crime against and engagement with orthodox Jews, and hate crime within university communities.

TRANSPARENCY

We found that many police forces have not been keeping ordered data about antisemitic hate crime. The Home Office has acted to remedy this with new crime reporting rules which mandate police forces to track all strands of hate crime separately, including antisemitism. This will mean that antisemitic hate crime can easily be tracked from the first report to the police, through to charging. The Crown Prosecution Service however still does not record whether it prosecutes those charged, and if so, what the outcome is. This makes it impossible to scrutinise the performance of the Crown Prosecution Service and, more broadly, the success of the criminal justice system as a whole, in tackling antisemitism.

We recommend recording and regular publication by the Crown Prosecution Service of data for each police force area showing prosecution decisions in cases involving antisemitism and the outcomes of any prosecutions, including sentencing.

METHODOLOGY

This report has been compiled using statistics gathered from all of the police forces in the United Kingdom. Under the Freedom of Information Act, all forces were requested to provide a breakdown of the number of antisemitic crimes and non-criminal incidents reported to them in each month of 2014 and 2015. In the case of antisemitic crimes, forces were also asked to provide the number of crimes involving violence, and the number of crimes resulting in charges being brought.

The result is the first National Antisemitic Crime Audit, providing the first analysis of police figures for antisemitic incidents across the United Kingdom.

INCIDENTS, CRIMES, VIOLENCE AND CHARGING

CRIMES AND NON-CRIMINAL INCIDENTS

When a matter is reported to a police force, it is normally logged as an "incident". An incident is a matter that has been reported to the police. If an incident is deemed by the police to be criminal, then its status is changed to that of being a "crime". A crime is any incident which is believed to have broken the law.

For example, a member of the public might report that they were called a "F***ing Jew" during a conversation. There are some circumstances in which it is a criminal

offence to call somebody a "F***ing Jew", but there are also circumstances where it does not constitute a criminal offence. In this example, if the comment was made inside a dwelling, it is likely that the matter would be logged as an incident, whereas if it happened at a demonstration, it is possible that the matter would be logged as an incident, and then recategorised as a crime.

There is justifiable concern that incident data is unreliable, because it includes any report made to the police that is not criminal, which means that incidents are unqualified and may have no connection to criminality at all. The Metropolitan Police Service handles incidents differently to other police forces, recording all reports as an allegation, and then classifying some allegations as crimes, the difference being that classification of an allegation as a crime does not remove it from the allegation data, so it could be counted as both an incident and a crime. For these reasons, incident data should only be used as a means of judging whether police forces received a higher or lower number of non-criminal complaints.

VIOLENT CRIMES

The Home Office sets standards for recording crimes which apply to all police forces. Our categorisation of "violent crimes" includes any antisemitic act falling into the Home Office categories of "homicide" or "violence with injury". We also include antisemitic acts falling within the sub-category of "racially or religiously aggravated assault without injury".

CHARGING

The Home Office has standardised the recording of case outcomes. We included any antisemitic crime whose outcome was recorded as "charged/summonsed".

DEALING WITH DISPARATE DATA

Each police force uses its own Crime Management System (CMS) for recording incidents and crimes. Some forces have adapted their CMS to include a specific flag for antisemitic crimes and incidents, whereas other have not.

FLAGGED ANTISEMITIC CRIMES AND INCIDENTS

In cases where the CMS has a specific flag for antisemitic crimes and incidents, it is normally left to the discretion of the investigating officer whether a crime or incident should be flagged as being antisemitic. It is beyond the scope of this present research to determine whether antisemitic crimes and incidents are being reliably flagged as such. For the purposes of this present research, if a crime or incident was flagged as being antisemitic, it was treated as being antisemitic, and crimes and incidents that were not flagged as being antisemitic have been excluded from the statistics presented.

KEYWORD SEARCHES FOR ANTISEMITIC CRIMES AND INCIDENTS

In cases where the CMS does not have a specific flag for antisemitic crimes and incidents, it is necessary to interrogate the information held by the CMS to try to extract details of antisemitic crimes and incidents. In the absence of a discrete flag for antisemitic crimes and incidents, it is possible to search for crimes and incidents flagged as racially or religiously motivated (it is settled law that, for legal purposes, Jews are considered to belong to a race as well as a religion¹), and then search within those results for keywords which are likely to be indicators that the crimes and incidents were antisemitic. For the purposes of this research, the keywords used were the following whole words: Jew, Jews, Jewish, Judaism, Semite, Semitic, Semitism, Antisemite, Antisemitic, Antisemitism, Yid, Yids, Yiddo, or Yiddish.

Police forces whose CMS did not use a specific flag for antisemitism, and who were therefore conducting keyword searches, tended to be police forces in whose jurisdiction antisemitic crimes and incidents were comparatively rare. Their searches tended to yield only a small number of crimes and incidents, which in some cases could then be individually checked to ensure that they were indeed antisemitic crimes and incidents.

¹ In *Mandla v Dowell-Lee* [1983] 2 AC 548, the law lords held that Sikhs were a racial group whose members could be defined by birth or adherence and Lord Fraser approved the decision in *King-Ansell v Police* [1979] 2 NZLR 531 that Jews formed a group with common ethnic origins for the purposes of the New Zealand Race Relations Act. Further support for the proposition that Jews are a racial group can be found in the cases of *R v JFS* [2009] UKSC 15 and *Seide v Gillette Industries Ltd* [1980] IRLR 427 — although these were not criminal cases. Nevertheless, it is settled law that in criminal cases, as in other legal fields, Jews are a racial grouping and not merely a religious group.

Every effort has been made to ensure that antisemitic crime and incident data obtained by means of keyword search is accurate, but such data will never be quite as accurate as data obtained from a CMS with a specific flag for antisemitic crimes and incidents. We have therefore provided data from each police force, including details of how that data was obtained.

WITHHELD DATA

Gloucestershire Constabulary refused to supply data using exemptions under the Freedom of Information Act on the basis that disclosing the requested information might reveal personal details and compromise ongoing investigations. We are working to overcome these objections as Gloucester Constabulary was simply asked to provide the same data as every other police force.

Police Scotland refused to supply data using exemptions under the Freedom of Information (Scotland) Act. We are proposing an information sharing agreement with Police Scotland which would resolve this issue.

LIMITED DATA

Under the Freedom of Information Act, police forces are permitted to decline to respond to requests for information which would take more than eighteen hours of police time to answer. Some police forces were unable to provide data on all antisemitic crimes and incidents because their data is in extreme disorder and it would have taken more than eighteen

hours, by their estimation, for a member of staff to provide the data we sought.

On this basis, Merseyside Police did not provide data about non-criminal antisemitic incidents, violent antisemitic crime or charged antisemitic crime and Bedfordshire Police, Devon and Cornwall Constabulary, Dorset Police, Dyfed-Powys Police, North Wales Police, Staffordshire Police and West Midlands Police did not provide data about non-criminal antisemitic incidents.

CONFIDENTIALITY

Some police forces which handled only a small number of antisemitic incidents or crimes over a given period did not provide the month in which an incident or crime took place, so as not to risk providing data from which information about individual cases could be deduced. In such cases, the incident or crime was treated as having happened in December of the year to which it related, as that is the last month when it could have taken place. In total, one incident fell into this category, and five crimes.

COMPARISONS

Police forces do not all record antisemitic crime in a uniform manner. Data gathered by way of keyword searches is not necessarily completely comparable across police forces, and it is possible that some antisemitic crime will have slipped through keyword searches.

RECORDING PRACTICES

The Home Office introduced new requirements for recording antisemitism which took effect in April 2016, mandating all forces to track all strands of hate crime separately, including antisemitism. The recording practices below were operating during 2014 and 2015.
